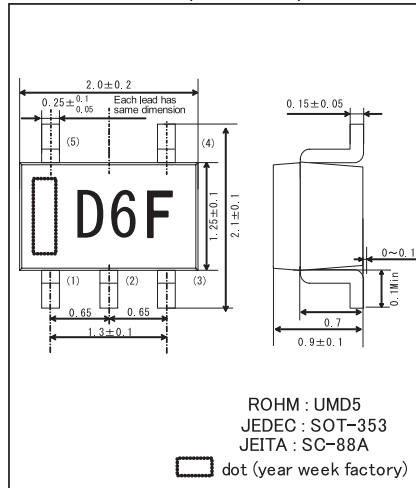

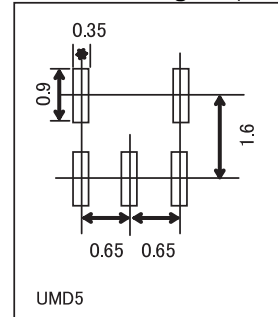

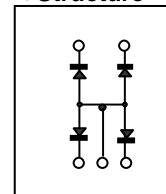

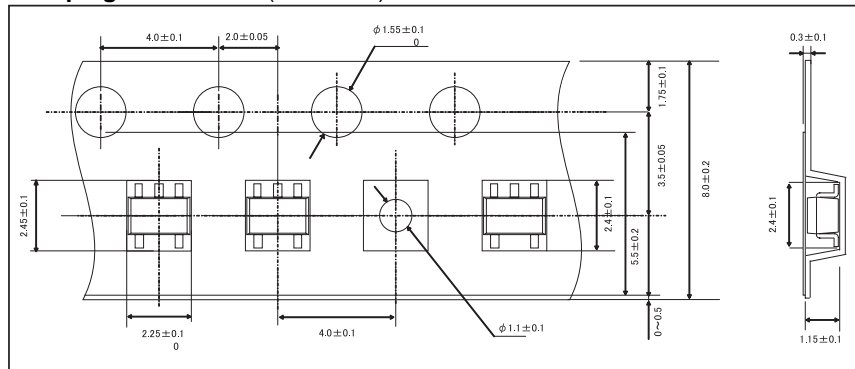

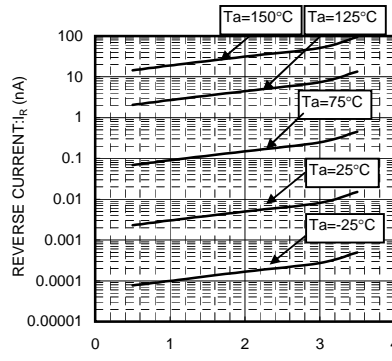

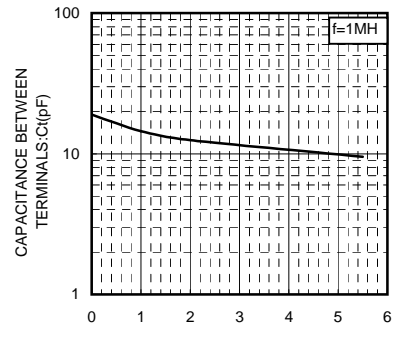

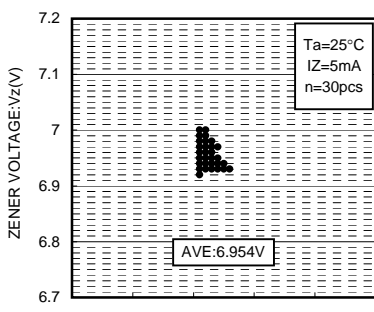

 $V_z$ - $I_z$  CHARACTERISTICS



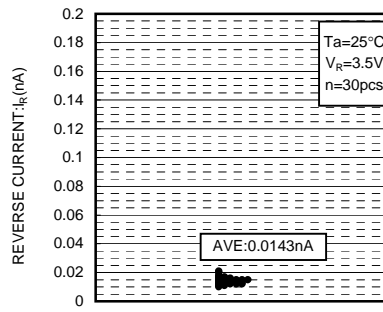
REVERSE VOLTAGE :  $V_R$ (V)  
 $V_R$ - $I_R$  CHARACTERISTICS



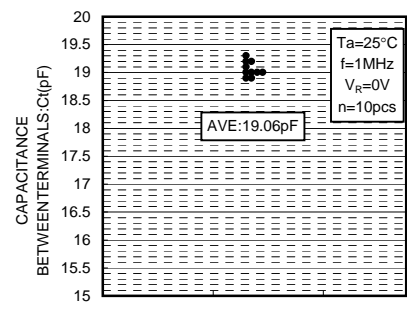
REVERSE VOLTAGE :  $V_R$ (V)  
 $V_R$ - $C_t$  CHARACTERISTICS



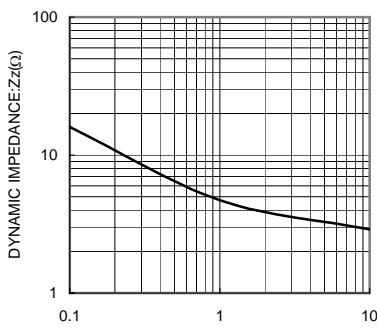
$V_z$  DISREION MAP



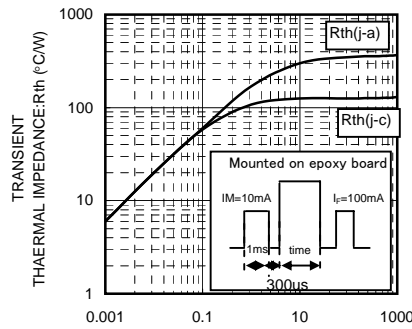
$I_R$  DISREION MAP
